NOTICE OF PUBLIC HEARING

DOG AND CAT ORDINANCE No. 2024-05

PLEASE TAKE NOTICE THAT the City of Rockland will conduct a public hearing on November 11, 2024, at 6:30 pm at Rockland City Hall, Rockland, Idaho 83271.

The proposed Dog and Cat Ordinance No. 2024-05 will replace in its entirety Chapter

14 DOGS of the current city ordinance.

Summary of proposed changes are as follows: SECTION 14-1 DEFINITIONS. Each of

the terms defined shall have the meaning as clearly required by the context. SECTION

14-2 CRUELTY TO ANIMALS. Specific acts and omissions defining cruelty.

SECTION14-3 COMMANDING AND ANIMAL TO AT-TACK, SECTION 14-4, WILD

AND EXOTIC ANIMALS. It is unlawful for any person to possess any wild or exotic

animal. Exotic animals defined. SECTION 14-5 KENNELS. Non-Commercial Kennels

applies to an establishment or premises with three (3) or more dogs over six (6) months

of age. Fee schedule: 3 dogs \$25, 4 dogs \$75.00, and 5 dogs \$150.00. SECTION 14-6

RABIES, DISEASE AND QUARANTINE. Afflicted Animals. SECTION 14-7 RUNNING

AT LARGE. "Running at Large" defined. SECTION 14-8 DISTURBANCE BY ANIMALS.

Prohibited: No owner or custodian shall permit their animal to make frequent or long

continued noise which unreasonably disturbs or annoys. SEC-TION 14-9 WASTE

MATTER. No animal owner or custodian shall permit an animal to deposit solid waste

matter on any property other than his or her own. SECTION 14-10 NUISANCE.

Nuisances enumerated. SECTION 14-11 VICIOUS DOGS. Confinement requirements.

Definition of assault and liability of owner. SECTION 14-12 IMPOUNDMENT. Lawful

impounding of animals. SECTION 14-3 INTERFERENCE WITH ANIMAL CONTROL

OFFICER. It is unlawful for any person to hinder any animal control officer or City of

Rockland representative. SECTION 14-14 INSPECTIONS; PENALTY. Violations of this

chapter and penalties set forth.
